For example, the sum of each of the race groups for non-Hispanics may not be the same as the estimate given for nonHispanics. These estimates will not match counts from the 2010 Census.

The data source for the Citizen Voting Age Population (CVAP) is the American Community Survey (ACS). The ACS is an ongoing survey by the U.S. Census Bureau sent to approximately 250,000 households each month.
The ACS estimates used to develop these data were collected from January 1, 2005 to December 31, 2009. The percentages of the citizen voting age population by race/ethnicity were estimated at the 2000 Census block group level. The block group level estimates were further allocated to the 2010 Census blocks to obtain estimates of the Citizen Voting Age Population by race/ethnicity.
