APPOINTMENTS:

a. ORANGE COUNTY CITY SELECTION COMMITTEE CHAIR AND VICE CHAIR

- (1) Mayor to serve as Committee Chair to the Orange County City Selection Committee. Any candidate who wishes to secure this seat must be a Mayor of an Orange County city at time of appointment and receive votes by the majority of the City Selection Committee. This appointment is for a term of one year. Term begins May 2025 and expires May 2026. This seat is currently held by David Shawver, Mayor of Stanton.
- (1) Mayor to serve as Committee Vice Chair to the Orange County City Selection Committee. Any candidate who wishes to secure this seat must be a Mayor of an Orange County city at time of appointment and receive votes by the majority of the City Selection Committee. This appointment is for a term of one year. Term begins May 2025 and expires May 2026. This seat is currently held by Gracie Van Der Mark, Huntington Beach City Council.

b. ORANGE COUNTY HOUSING FINANCE TRUST BOARD OF DIRECTORS

• (1) Mayor/Council Member whose city is a current member of the Trust, is not currently on the Board of Directors representing the Central, North or South Service Planning Areas and whose city population is under 60,000, to serve pursuant to the Orange County Housing Finance Trust Joint Powers Agreement and its adopted bylaws. Voting cities are Trust member cities with a population under 60,000 and not already represented on the Trust Board. Those cities are: Dana Point, Fountain Valley, San Juan Capistrano, Laguna Beach, Los Alamitos, Seal Beach, Stanton, Placentia, Aliso Viejo and Laguna Hills. This seat is for a two-year term beginning date of appointment. This seat is currently held by Mike Frost, Dana Point City Council.

c. ORANGE COUNTY OLDER ADULTS ADVISORY COMMISSION

- (1) Individual to serve as 2nd District Representative 2 on the Council. To secure this seat, the candidate must obtain two votes comprising a majority of the cities within the Second supervisorial district. Those cities are Orange, Santa Ana and Tustin. This appointment is for a two-year term that begins January 1, 2024, and expires December 31, 2025. This seat is currently held by Barbara Sloate, Newport Beach.
- (1) Individual to serve as 4th District Representative 1 on the Commission. To secure this seat, the candidate must obtain four votes comprising a majority of the cities within the Fourth supervisorial district. Those cities are Anaheim, Brea, Buena Park, Fullerton, La Habra, Placentia and Stanton. This appointment is for a two-year term that began January 1, 2025, and expires December 31, 2026. This seat is currently vacant.

d. ORANGE COUNTY WASTE MANAGEMENT COMMISSION

- (1) Mayor/Council Member to serve as the Elected Official At-Large Representative on the commission. To secure this seat, the candidate must obtain votes by the majority of the City Selection Committee. This appointment if for a three-year term beginning June 1, 2025 and expires May 31, 2028. This seat is currently held by Dave Shawver, Stanton City Council.
- (1) Mayor/Council Member to serve as the 1st District Representative on the Commission. To secure this seat, the candidate must obtain five votes comprising a majority of the cities within the First supervisorial district. Those cities are Cypress, Fountain Valley, Garden Grove, Huntington Beach, La Palma, Los Alamitos, Seal Beach and Westminster. This appointment if for a three-year term beginning June 1, 2025 and expires May 31, 2028. This seat is currently held by Ted Bui, Fountain Valley City Council.
- (1) Mayor/Council Member to serve as the 2nd District Representative on the Commission. To secure this seat, the candidate must obtain two votes comprising a majority of the cities within the Second supervisorial district. Those cities are Orange, Santa Ana and Tustin. This appointment if for a three-year term beginning June 1, 2025 and expires May 31, 2028. This seat is currently held by Arianna Barrios, Orange City Council.
- (1) Mayor/Council Member to serve as the 3rd District Representative on the Commission. To secure this seat, the candidate must obtain four votes comprising a majority of the cities within the Third supervisorial district. Those cities are Irvine, Lake Forest, Mission Viejo, Rancho Santa Margarita, Villa Park and Yorba Linda. This appointment if for a three-year term beginning June 1, 2025 and expires May 31, 2028. This seat is currently held by Janice Lim, Yorba Linda City Council.
- (1) Mayor/Council Member to serve as the 4th District Representative on the Commission. To secure this seat, the candidate must obtain four votes comprising a majority of the cities within the Fourth supervisorial district. Those cities are Anaheim, Brea, Buena Park, Fullerton, La Habra, Placentia and Stanton. This appointment if for a three-year term beginning June 1, 2025 and expires May 31, 2028. This seat is currently held by Christine Marick, Brea City Council.
- (1) Mayor/Council Member to serve as the 5th District Representative on the Commission. To secure this seat, the candidate must obtain six votes comprising a majority of the cities within the Fifth supervisorial district. Those cities are Aliso Viejo, Costa Mesa, Dana Point, Laguna Beach, Laguna Hills, Laguna Niguel, Laguna Woods, Newport Beach, San Clemente and San Juan Capistrano. This appointment if for a three-year term beginning June 1, 2025 and expires May 31, 2028. This seat is currently held by John Taylor, San Juan Capistrano City Council.

e. ORANGE COUNTY TRANSPORTATION AUTHORITY

• (1) Mayor/Council Member to serve as the 3rd Supervisorial District Board Member on the Orange County Transportation Authority's Board of Directors, to be appointed on a population weighted vote basis. To secure this seat, the candidate must obtain votes comprising a majority of the population weight from the cities within the Third Supervisorial District. Those cities are Irvine, Lake Forest, Mission Viejo, Rancho Santa Margarita, Villa Park and Yorba Linda. This appointment is to complete a two-year term that began January 1, 2025 and expires December 31, 2026. This seat is currently vacant.

f. AIRPORT LAND USE COMMISSION

• (1) Mayor/Council Member to serve as the At Large Commissioner on the Commission. To secure this seat, the candidate must obtain votes of the majority of the City Selection Committee. This appointment is for a four-year term that began May 6, 2025 and will expire May 7, 2029. This seat is currently held by Shelley Hasselbrink, Los Alamitos City Council.

g. EMERGENCY MEDICAL CARE COMMITTEE

- (1) Mayor/Council Member to serve as the City Member Representative on the Committee. To secure this seat, the candidate must obtain votes by the majority of the City Selection Committee. This appointment is to complete a two-year term that began July 1, 2024 and expires June 30, 2026. This seat is currently vacant.
