- **APPOINTMENTS:**

- a. **CITY ENGINEERS FLOOD CONTROL ADVISORY COMMITTEE**

- **(1) City Engineer or City Director of Public Works** to serve as **3<sup>rd</sup> District Member** on the City Engineers Flood Control Advisory Committee. To secure this seat, the candidate must be a City Engineer or City Director of Public Works and a member of The City Engineers Association of Orange County (CEAOC). The candidate must obtain four votes comprising a majority of the cities within the Third supervisorial district. Those cities are Irvine, Lake Forest, Mission Viejo, Rancho Santa Margarita, Villa Park and Yorba Linda. This appointment is for a three-year term that will begin date of appointment. This seat is currently held by Jamie Lai, Yorba Linda. CEAOC nominates Jamie Lai, Yorba Linda.
- **(1) City Engineer or City Director of Public Works** to serve as **4<sup>th</sup> District Member** on the City Engineers Flood Control Advisory Committee. To secure this seat, the candidate must be a City Engineer or City Director of Public Works and a member of The City Engineers Association of Orange County (CEAOC). The candidate must obtain four votes comprising a majority of the cities within the Fourth Supervisorial District. Those cities are Anaheim, Brea, Buena Park, Fullerton, La Habra, Placentia and Stanton. This appointment is for a three-year term that will begin date of appointment. This seat is currently held by Mina Mikhael, Buena Park. CEAOC nominates Mina Mikhael, Buena Park.

- b. **ORANGE COUNTY OPERATIONAL AREA EXECUTIVE BOARD**

- **(1) City Manager** to serve as the **City Manager Representative** on the Board. This appointment is a joint appointment with the Orange County City Managers Association. To secure this seat, the candidate must obtain votes by the majority of the City Selection Committee. This appointment is for a two-year term that begins January 1, 2026, and expires December 31, 2027. This seat is currently held by Jim Sadro, La Habra. The Orange County City Managers Association nominates TBD.
- **(1) City Manager** to serve as the **City Manager Representative - Alternate** on the Board. This appointment is a joint appointment with the Orange County City Managers Association. To secure this seat, the candidate must obtain votes by the majority of the City Selection Committee. This appointment is for a two-year term that begins January 1, 2026, and expires December 31, 2027. This seat is currently Vacant. The Orange County City Managers Association nominates TBD.

**c. ORANGE COUNTY OLDER ADULTS ADVISORY COMMISSION**

- **(1) Individual** to serve as **1<sup>st</sup> District Representative 2** on the Commission. To secure this seat, the candidate must obtain five votes comprising a majority of the cities within the First supervisorial district. Those cities are Cypress, Fountain Valley, Garden Grove, Huntington Beach, La Palma, Los Alamitos, Seal Beach and Westminster. This appointment is for a two-year term that begins January 1, 2026, and expires December 31, 2027. This seat is currently Vacant.
- **(1) Individual** to serve as **2<sup>nd</sup> District Representative 2** on the Commission. To secure this seat, the candidate must obtain two votes comprising a majority of the cities within the second supervisorial district. Those cities are Orange, Santa Ana and Tustin. This appointment is for a two-year term that begins January 1, 2026, and expires December 31, 2027. This seat is currently held by Barbara Sloate, Newport Beach.
- **(1) Individual** to serve as **3<sup>rd</sup> District Representative 2** on the Commission. To secure this seat, the candidate must obtain four votes comprising a majority of the cities within the Third supervisorial district. Those cities are Irvine, Lake Forest, Mission Viejo, Rancho Santa Margarita, Villa Park and Yorba Linda. This appointment is for a two-year term that begins January 1, 2026, and expires December 31, 2027. This seat is currently held by Janice Lim, Yorba Linda City Council.
- **(1) Individual** to serve as **4<sup>th</sup> District Representative 2** on the Commission. To secure this seat, the candidate must obtain four votes comprising a majority of the cities within the Fourth supervisorial district. Those cities are Anaheim, Brea, Buena Park, Fullerton, La Habra, Placentia and Stanton. This appointment is for a two-year term that begins January 1, 2026, and expires December 31, 2027. This seat is currently held by Marty Simonoff, Brea City Council.
- **(1) Individual** to serve as **5<sup>th</sup> District Representative 1** on the Commission. To secure this seat, the candidate must obtain six votes comprising a majority of the cities within the Fifth supervisorial district. Those cities are Aliso Viejo, Costa Mesa, Dana Point, Laguna Beach, Laguna Hills, Laguna Niguel, Laguna Woods, Newport Beach, San Clemente and San Juan Capistrano. This appointment is for a two-year term that begins January 1, 2026, and expires December 31, 2027. This seat is currently held by Howard Hart, San Juan Capistrano City Council.

#### **d. ORANGE COUNTY WASTE MANAGEMENT COMMISSION**

- **(1) Mayor/Council Member** to serve as the **2<sup>nd</sup> District Representative** on the Commission. To secure this seat, the candidate must obtain two votes comprising a majority of the cities within the Second supervisorial district. Those cities are Orange, Santa Ana and Tustin. This appointment is for a three-year term beginning June 1, 2025 and expires May 31, 2028. This seat is currently held by Arianna Barrios, Orange City Council.
- **(1) Mayor/Council Member** to serve as the **5<sup>th</sup> District Representative** on the Commission. To secure this seat, the candidate must obtain six votes comprising a majority of the cities within the Fifth supervisorial district. Those cities are Aliso Viejo, Costa Mesa, Dana Point, Laguna Beach, Laguna Hills, Laguna Niguel, Laguna Woods, Newport Beach, San Clemente and San Juan Capistrano. This appointment is for a three-year term beginning June 1, 2025 and expires May 31, 2028. This seat is currently held by John Taylor, San Juan Capistrano City Council.

#### **e. SAN GABRIEL AND LOWER LOS ANGELES RIVERS AND MOUNTAINS CONSERVANCY (RMC)**

- **(1) Mayor/Council Member** to serve as **Orange County's Representative** to the San Gabriel and Lower Los Angeles Rivers and Mountains Conservancy. To be eligible for this seat, the mayor/council member must represent a city member of the Orange County Division of the League of California Cities (League) that borders the San Gabriel River or one of its tributaries; current division members in this area include Anaheim, Brea, Buena Park, Cypress, Fullerton, La Habra, La Palma, Los Alamitos, Placentia and Seal Beach. To secure this seat, the candidate must obtain votes by the majority of the City Selection Committee cities that are members of the League. This is for a two-year term that begins January 1, 2026, and expires December 31, 2027. This seat is currently held by Fred Jung, Fullerton City Council.
- **(2) Mayors/Council members** to be nominated as the **Governor's Appointee** on the San Gabriel and Lower Los Angeles Rivers and Mountains Conservancy. To be eligible for this seat, the mayor/council member must represent a city member of the Orange County Division of the League of California Cities that borders the San Gabriel River or one of its tributaries; eligible cities are Anaheim, Brea, Buena Park, Cypress, La Habra, La Palma, Los Alamitos, Placentia, and Seal Beach. To secure this nomination, the candidates must obtain votes by a majority of the City Selection Committee. This term begins upon successful appointment of one (1) of the nominees by the Governor's Office and expires two years from date of appointment. This seat is currently held by Joe Kalmick, Seal Beach City Council.

**f. ORANGE COUNTY TRANSPORTATION AUTHORITY BOARD OF DIRECTORS**

- **(1) Mayor/Council Member** to serve as the **1<sup>st</sup> Supervisorial District Board Member** on the Orange County Transportation Authority's Board of Directors, to be appointed on a **one city/one vote** basis. The candidate must obtain votes comprising a majority of the cities within the First Supervisorial District. Those cities are Cypress, Fountain Valley, Garden Grove, Huntington Beach, La Palma, Los Alamitos, Seal Beach and Westminster. This appointment is for a two-year term that will begin January 1, 2026, and expire December 31, 2027. This seat is currently held by Stephanie Klopfenstein, Garden Grove City Council.
- **(1) Mayor/Council Member** to serve as the **2<sup>nd</sup> Supervisorial District Board Member** on the Orange County Transportation Authority's Board of Directors, to be appointed on a **population weighted vote** basis. To secure this seat, the candidate must obtain votes comprising a majority of the population weight from the cities within the Second Supervisorial District. Those cities are Orange, Santa Ana and Tustin. This appointment is for a two-year term that will begin January 1, 2026, and expire December 31, 2027. This seat is currently held by Valerie Amezcua, Santa Ana City Council.
- **(1) Mayor/Council Member** to serve as the **3<sup>rd</sup> Supervisorial District Board Member** on the Orange County Transportation Authority's Board of Directors, to be appointed on a **one city/one vote** basis. The candidate must obtain votes comprising a majority of the cities within the Third Supervisorial District. Those cities are Irvine, Lake Forest, Mission Viejo, Rancho Santa Margarita, Villa Park and Yorba Linda. This appointment is for a two-year term that will begin January 1, 2026, and expire December 31, 2027. This seat is currently held by Mark Tettermer, Lake Forest City Council.
- **(1) Mayor/Council Member** to serve as the **4<sup>th</sup> Supervisorial District Board Member** on the Orange County Transportation Authority's Board of Directors, to be appointed on a **population weighted vote** basis. To secure this seat, the candidate must obtain votes comprising a majority of the population weight from the cities within the Fourth Supervisorial District. Those cities are Anaheim, Brea, Buena Park, Fullerton, La Habra, Placentia and Stanton. This appointment is for a two-year term that will begin January 1, 2026, and expire December 31, 2027. This seat is currently held by Carlos Leon, Anaheim City Council.
- **(1) Mayor/Council Member** to serve as the **5<sup>th</sup> Supervisorial District Board Member** on the Orange County Transportation Authority's Board of Directors, to be appointed on a **population weighted vote** basis. To secure this seat, the candidate must obtain votes comprising a majority of the population weight from the cities within the Fifth Supervisorial District. Those cities are Aliso Viejo, Costa Mesa, Dana Point, Laguna Beach, Laguna Hills, Laguna Niguel, Laguna Woods, Newport Beach, San Clemente and San Juan Capistrano. This appointment is for a two-year term that will begin January 1, 2026, and expire December 31, 2027. This seat is currently held by John Stephens, Costa Mesa City Council.
